Sunday, May 11<sup>th</sup> is Mother's Day, and it is only early May, but most of our members, if not all are thinking about, and looking forward to the coming summer months. That is why we spend our summer's here, or retired here to live year-round. Getting everything ready to enjoy the summer often seems like a full time job. With everything you have on your plates our Fall Festival seems like something way off in the distant future, but it's not... Actually, it starts 4 months from the day of our May meeting. We are planning on having two (2) Recruiting and Fund-Raising Booths, "if we have enough volunteers to man them." Friday the 19th and Saturday the 20th I am asking every member to consider, and if you are able; Volunteer 2 Hours. If each of our members, "currently 236" volunteers 2 hours that's 472-man hours. Each booth will require a minimum of 12 men for 2 hour shifts each per day = 24-man hours x 2 booths = 48-man hours. Bottom Line, we need 24 members to volunteer 2 hours of their time to have minimum coverage in 2 booths for 2 days. Hoping to have much more than minimum coverage, ideally have 4 men in each booth at all times...





